## 4. QUALITY ASSURANCE & QUALITY CONTROL

Major Visual Defects (Inspection Level GI, AQL ≤ 4.0) – Defects that disrupt the glove's function for its intended use or that may cause undesirable user experience.

The gloves are manufactured using Good Manufacturing Practices (cGMP) and adhere to ISO 25518:2021.
